PARTIAL RELEASE OF MORTGAGE

THIS PARTIAL RELEASE OF MORTGAGE (this "Release"), made as of February 6, 2004, by **LIBERTY PARK JOINT VENTURE, LLP**, an Alabama limited liability partnership ("Lender").

1. 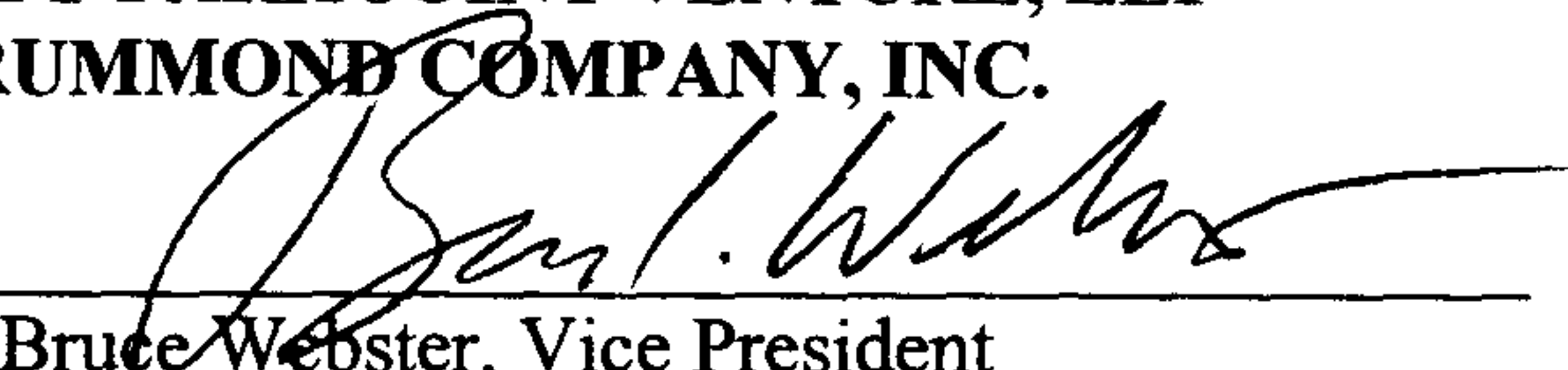
As to all other real property described and conveyed in the Mortgage, the lien and operation thereof shall remain in full force and effect, unaffected by this Release.
