This agreement is made and entered into on this 18 Day of February, 2004 by Countrywide Bank, \*\* , (hereafter "Mortgagee") in favor of COUNTRYWIDE HÖME LOANS, INC., (nereafter "Mortgage Company"), its successors and assigns.

- That the lien of mortgage executed by the Borrower to the Mortgagee is and shall be subordinated to the lien of the mortgage executed by the Borrower to the Mortgage Company Mortgage.
- 2. That the mortgage executed by the Borrower to Mortgagee is and shall be subordinated both in lien and payment to the mortgage executed by the Borrower to the Mortgage Company to the extent that the mortgage to Lender is, as a result of this Subordination Agreement, a validly perfect first lien security interest in the above described property.
- 3. That to the extent the mortgage of the Mortgage Company is, as result of this Subordination Agreement a validly perfect first lien security interest in the abovedescribed property, the lien of the mortgage executed by Borrower to Mortgage Company shall not be affected or impaired by a judicial sale under a judgment recovered the mortgage made by Borrower to Mortgagee, but any such shall be subject to the lien of the said mortgage executed by the Borrower to Mortgage Company as well as any judgment obtained upon the bond or note secured thereby.
