(legal description of subject property)

Property located in the NE ¼ of the NE ¼ of Section 15, Township 21 South, Range 3 West, Shelby County, Alabama, described as follows:

Commence at the NW corner of the NE ¼ of the NE ¼ of Section 15, Township 21 South, Range 3 West; thence run South 0°52'06" West along the West line of said ¼ - ¼ section 80.72 feet to a point, said point being on the South right of way line of County Road 26 (80 foot right of way), said point also being the point of beginning; thence run South 86°20'40" East along said right of way line 131.28 feet to a point, said point being the beginning of a curve to the left, said curve having a central angle of 2°11'54" and a radius of 2135.09 feet, said curve being subtended by a chord which bears South 87°26'37" East a distance of 81.91 feet; thence run Easterly along the arc of said curve and along said right of way 81.92 feet; thence run South 0°52'06" West 201.20 feet; thence run North 89°07'54" West 213.00 feet to a point on the West line of said ¼ - ¼ section; thence run North 0°52'06" East along said West line, 210.00 feet to the point of beginning; being situated in Shelby County, Alabama.
