

## State of Alabama Domestic Limited Liability Company

## Articles of Organization of Titan Enterprises, LLC

The undersigned, acting pursuant to the Alabama Limited Liability Company Act, as last amended, hereby adopt the following Articles of Organization:

FIRST: The name of the Limited Liability Company is: Titan Enterprises, LLC.

**SECOND:** The period of duration is fifty (50) years.

THIRD: The purposes for which the Limited Liability Company is organized are:

- (a) To conduct book keeping and administrative services on a contract basis for business enterprises and individuals;
- (b) To purchase, take, receive, lease or otherwise acquire, own, hold, improve, use, sell and otherwise deal in or with, real or personal property, or any interest therein, wherever situated, and to sell, convey, mortgage, pledge, lease, exchange, transfer and otherwise dispose of real or personal property, or any interest therein;
- (c) To transact any or all lawful business permitted under the Alabama Limited Liability Company Act.

**FOURTH:** The location and street address of the initial registered office shall be: 106A Main Street, Alabaster, AL 35007, and the initial registered agent is at said address is Jackson H. Smith.

**FIFTH:** The name and address of the initial member of the Limited Liability Company is:

**SIXTH:** The name and address of the initial Operating Manager who is to serve until the first annual meeting of the members or until his successor is elected and qualified, is Jackson H. Smith.

**SEVENTH:** The Limited Liability Company shall have the right to admit additional members to the Limited Liability Company upon unanimous consent of all of the members of the Limited Liability Company.

**EIGHTH:** The Limited Liability Company, to the extent allowed by law, shall be taxed for all purposes as a sole proprietorship.

**NINTH:** The members of the Limited Liability Company shall have the right to continue the business of the Limited Liability Company following an act of dissolution or disassociation of a member, or the occurrence of any other event, which terminates the continued membership of a member of the Limited Liability Company.
