THIS FORECLOSURE DEED made this 10<sup>th</sup> day of February, 2004, between ROBERT J. HELMANDOLLAR and CHRISTINA D. HELMANDOLLAR, husband and wife, Parties of the First Part, and CHASE MANHATTAN MORTGAGE CORPORATION, Party of the Second Part;

W I T N E S S E T H:
