KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 29th day of September, 2000, Keith N. Wade Jr. and Brittany L. Wade, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Professionals, Inc., an Alabama Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 2000-35360, said mortgage having subsequently been transferred and assigned to Trustmark National Bank, by instrument recorded in Instrument Number 2000-35361, in the aforesaid Probate Office; and
