

ARTICLES OF INCORPORATION OF MHR SERVICES, INC.

Pursuant to Alabama Code 1975, as amended, Section 10-2B-2.02, the following Articles of Incorporation are set out:

FIRST: **NAME:** The name of the corporation is MHR Services, Inc.

SECOND: **DURATION:** The period of its duration is perpetual.

THIRD: **PURPOSE:** The purposes for which the corporation is organized are:

1. Transaction of any and all lawful business for which corporations may be incorporated under Alabama Code 1975 Section 10-2B-1.01 et seq.
2. To engage in the business of to acquire and manage real properties and any other similar commercial enterprise within or without the State of Alabama, and to obtain any and all licenses necessary to the conduct of the business of the corporation.
3. To own, operate and/or lease automobiles, trucks, or other means of transportation necessary or incidental to the corporation's business.
4. To do and engage in any business which a natural person can do.
5. To acquire, purchase, hypothecate, own, hold or sell any real or personal property of any kind, nature or description whatsoever, wherever situated; to acquire, purchase, hypothecate, own, hold and sell chooses in action, notes, mortgages, accounts, contracts, bonds and any evidence of indebtedness of any and every character whatsoever.
6. To manufacture, purchase or otherwise acquire, and to hold, own mortgage or otherwise lend, pledge, lease, sell, assign, exchange, transfer or in any manner dispose of, invest, deal and trade in and with goods, wares, merchandise and personal property of any and every class and description, within or without the State of Alabama.
7. To guarantee, purchase, or otherwise acquire, hold, sell, assign, transfer, mortgage, pledge or otherwise dispose of shares of capital stock, bonds, promissory notes, or other evidence of indebtedness created by, or the contracts or obligations of, other corporations and while the holder of such stock or other securities, to exercise all the rights and privileges or ownership, including the right to vote thereon, to the same extent as a natural person might or could do.
8. To purchase or otherwise acquire, apply for, register, hold, use, sell or in any manner dispose of, and to grant licenses or other rights in and in any manner deal with patents, trademarks, trade names, rights and licenses secured under letters patent, copyrights or otherwise.
9. To enter into, make and perform contracts of every kind for any lawful purpose with any person, firm, association or corporation, town, city, county, body politic, state, territory, government or colony or dependency thereof.

10. To borrow or lend money with or without security for any of the purposes of the corporation and to draw, make, accept, endorse, discount, execute, issue, sell, pledge, or otherwise dispose of promissory notes, drafts, bills of exchange, warrants, bonds, debentures, and other negotiable or non-negotiable, transferable or non-transfer instruments and evidences of indebtedness and to secure the payment thereof and the interest thereon by mortgage or pledge, conveyance or assignment in trust of the whole or any part of the property of the corporation at the time owned or thereafter acquired.
11. To purchase, acquire, hold, subdivide, develop and operate real estate, to erect buildings thereon, and to sell, lease, maintain, own, repair and operate such properties.
12. To purchase or otherwise acquire its own shares of stock, (so far as permitted by law) and its bonds, debentures, notes, script, or there securities, or evidence of indebtedness, and to hold, sell, transfer or reissue the same.
13. To have one(1) or more offices to conduct any or all of its operations in business and to promote its objects within or without the State of Alabama, without restriction as to place or amount.
14. To carry on any other business in connection with any other objects and purposes herein set forth.
15. To do any or all of the things herein set forth as principal, agent, contractor, trustee or otherwise, along or in company with others.
16. The objects and purposes specified herein shall be regarded as independent objects and purposes and except where otherwise expressed, shall be in no way limited nor restricted by reference to any inference from the terms of any other clause or paragraph of these Articles of Incorporation. The foregoing enumeration shall be construed both as objects and powers and shall not be held to limit or restrict in any manner the general powers conferred on this corporation by the laws of the State of Alabama.

FOURTH: AUTHORIZED SHARES : The corporation is authorized to issue One Thousand (1,000) shares of common stock. There shall only be one class of stock.

FIFTH: REGISTERED AGENT AND REGISTERED OFFICE: The street address of the corporation's initial registered office is 2535 Elizabeth Drive, Pelham, AL 35124 and the name of the initial registered agent at such office is : Cynthia K. Pace.

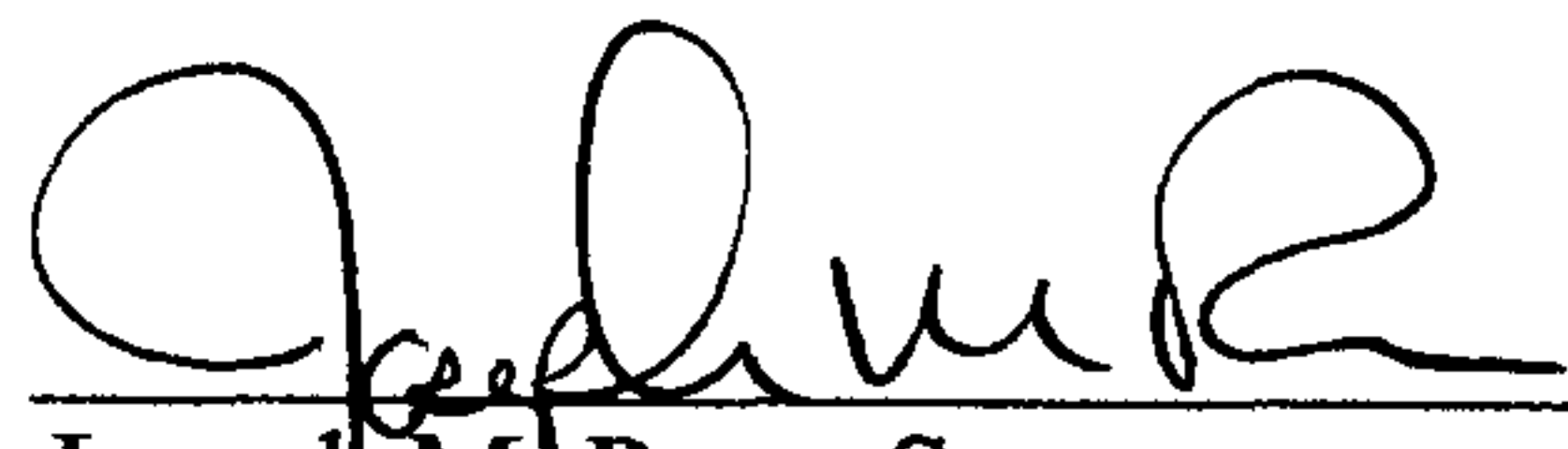
SIXTH: INCORPORATOR: The name and address of each incorporator is:

EIGHTH: LIMITATION OF LIABILITY: No director or shareholder of the corporation shall be liable to the corporation for money damages for any action taken, or any failure to take any action, as a director or as a shareholder, except liability for (1) the amount of a financial benefit received by a director or shareholder to which he or she is not entitled; (ii) an intentional infliction of harm on the corporation; (iii) a violation of Alabama Code 1975 Section 10-2B-8.33; and (iv) an intentional violation of criminal law; or (v) a breach of the director's duty of loyalty to the corporation or its shareholders.
