## ASSIGNMENT OF LAND LEASE

Prior to default, Lessee shall have the right to continue to exercise all of its possessory rights with respect to the said location, provided however, that Lessor may enter thereon at any time deemed necessary and appropriate by it to inspect and protect its interest in the lease equipment. In the event that consent by a landlord or any other person, firm or corporation is necessary in order to make the provisions of this paragraph legally enforceable, Lessee agrees to forthwith obtain such agreement at its own cost and expense. It is understood and agreed, however, that the Lessor does not hereby undertake or assume any obligation for the payment of rental or for the upkeep or maintenance of the said location.
