Said property is conveyed subject to the following:

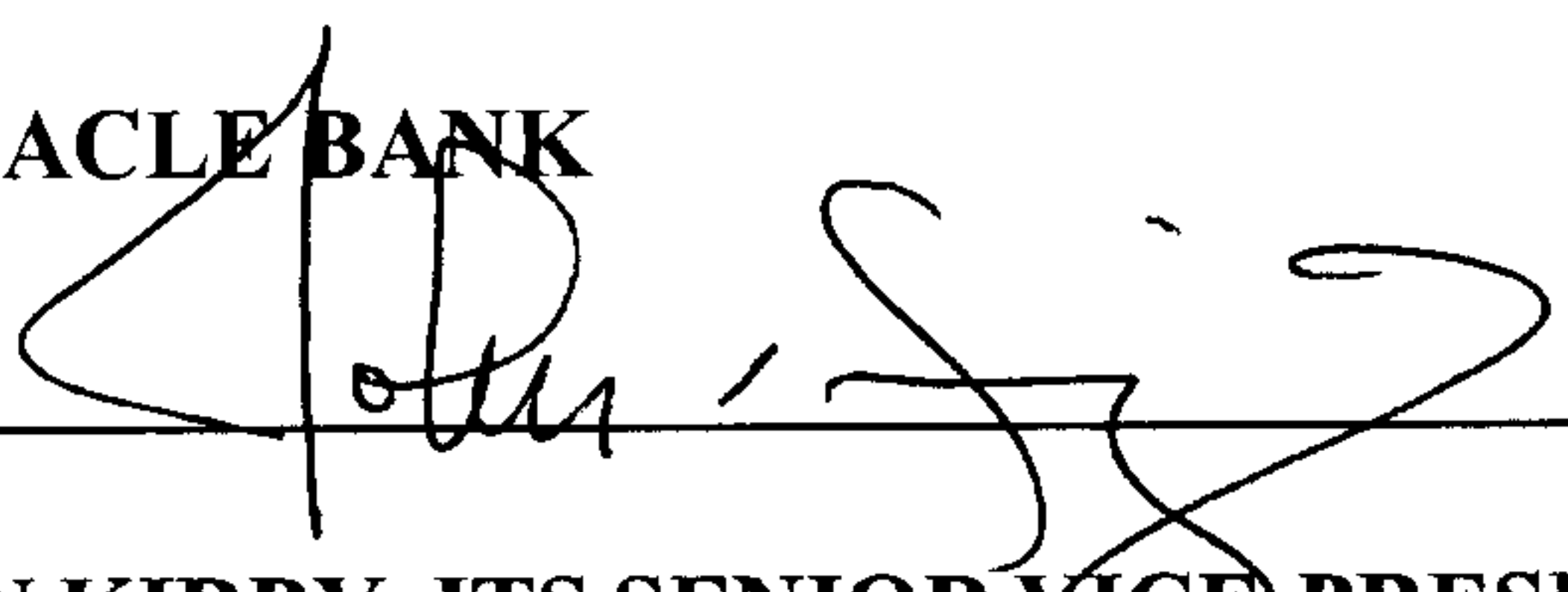
1. Ad valorem taxes for tax year 2004 due October 1, 2004 and delinquent January 1, 2005 and for all subsequent years thereafter.

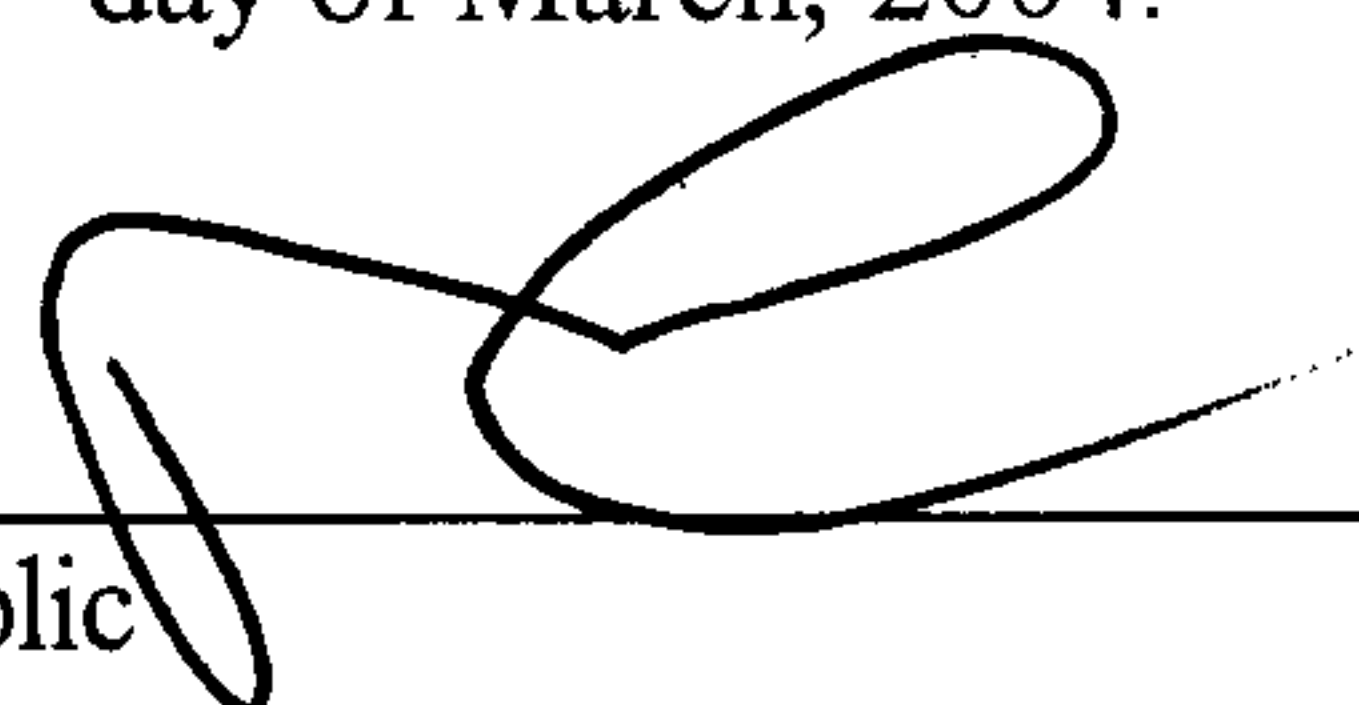
