KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of One Hundred Nine Thousand Nine Hundred and 00/100 (\$109,900.00) DOLLARS, and other good and valuable consideration, this day in hand paid to the undersigned GRANTOR, **Keystone Building Co., Inc., a corporation** (hereinafter referred to as GRANTOR), the receipt whereof is hereby acknowledged, the GRANTOR does hereby give, grant, bargain, sell and convey unto the GRANTEES, **Kevin Cofer and Nichole Cofer, husband and wife**, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of SHELBY, State of Alabama, to-wit:

Lot 21, according to Resurvey of Carrington Subdivision - Sector II as recorded in Map Book 26, Page 141 in the Office of the Judge of Probate of Shelby County, Alabama; being situated in Shelby County, Alabama. Mineral and mining rights excepted.

\$87,920.00 of the above-recited purchase price was paid from a mortgage loan closed simultaneously herewith.

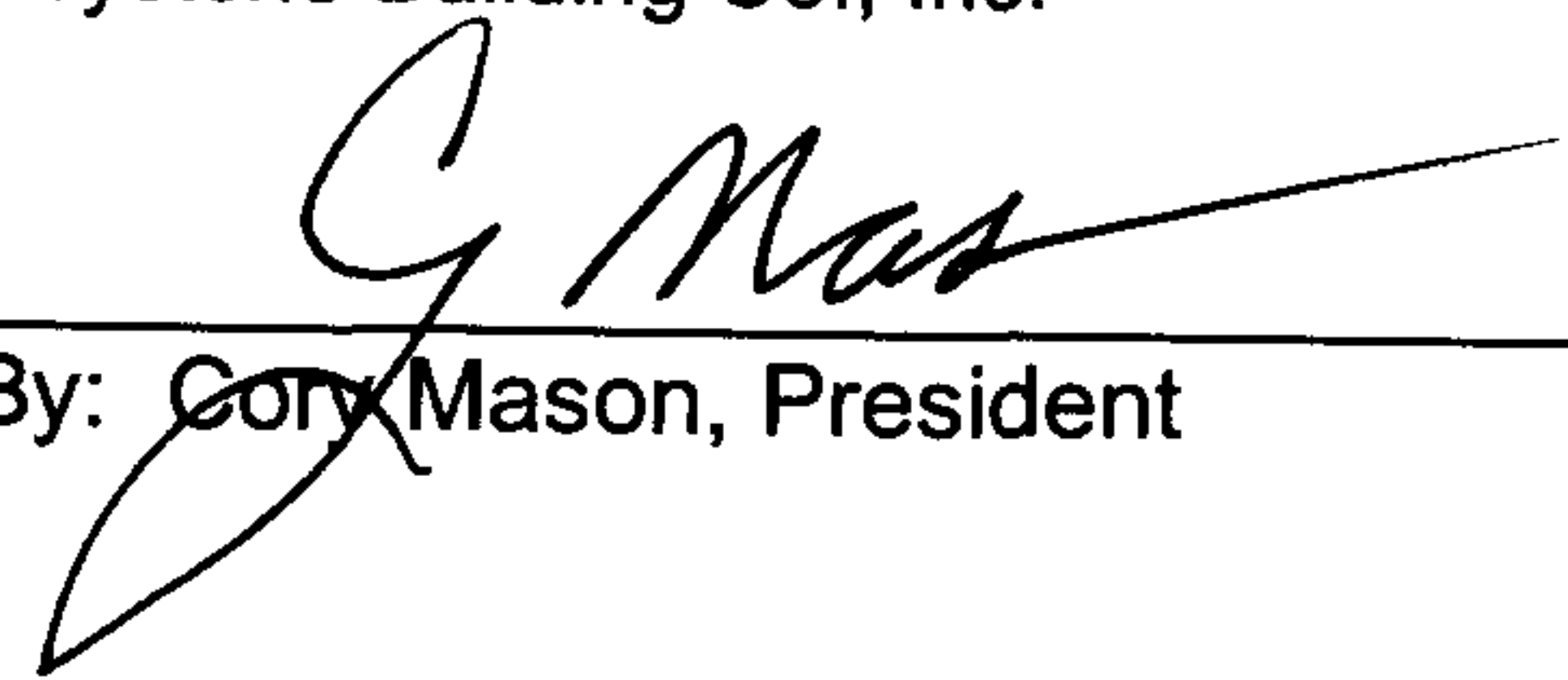
Keystone Building Co., Inc. and Keystone Building, Inc. are one and the same entity.

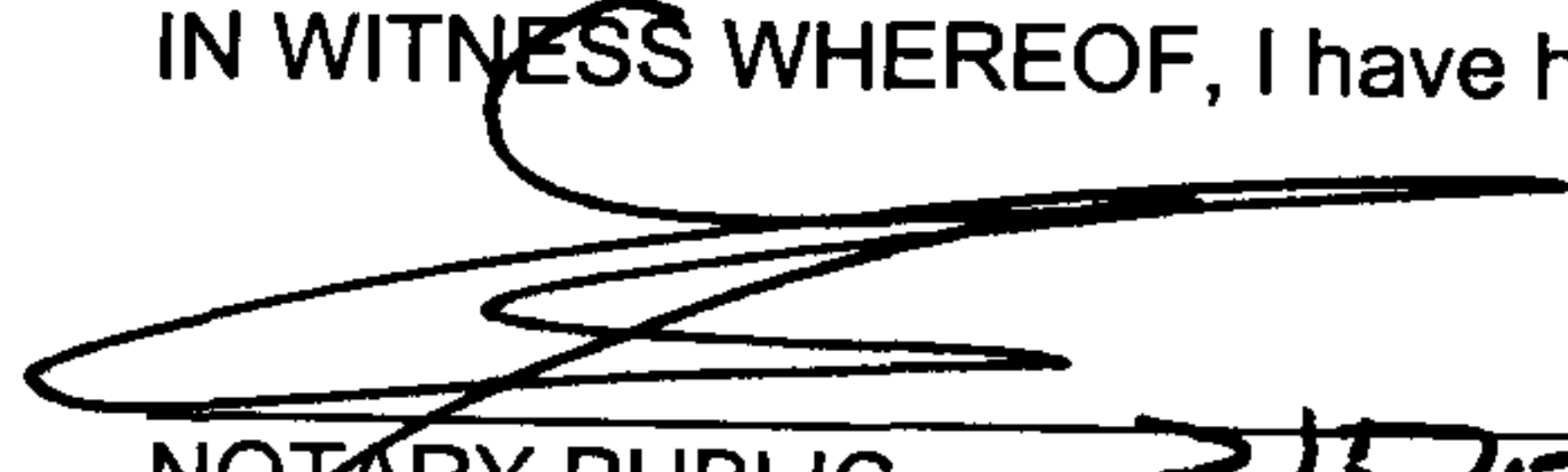
