KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of Two Hundred Twenty-Nine Thousand Four Hundred Fifty and 00/100 (\$229,450.00) DOLLARS, and other good and valuable consideration, this day in hand paid to the undersigned GRANTOR, **P.D. Bailey Homes, Inc., a corporation** (hereinafter referred to as GRANTOR), the receipt whereof is hereby acknowledged, the GRANTOR does hereby give, grant, bargain, sell and convey unto the GRANTEES, **Paul J. Wayboer and Brenda L. Wayboer, husband and wife**, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of SHELBY, State of Alabama, to-wit:

Lot 15-A, according to the Survey of Deer Ridge Lakes, Sector 3, as recorded in Map Book 31, page 107, in the Probate Office of Shelby County, Alabama. Mineral and mining rights excepted

Subject to existing easements, current taxes, restrictions and covenants, set-back lines and rights of way, if any, of record.


\$183,550.00 of the above-recited purchase price was paid from a mortgage loan closed simultaneously herewith.
