


RESOLUTION NO. 3106-04

WHEREAS, **The Cove at Greystone Phase II Subdivision** has been inspected by the Inspection Services Department of the City of Hoover and it has been determined that the required repairs and improvements have been made to this roadway and hereby recommend that the Hoover City Council accept this portion of the **The Cove at Greystone Phase II Subdivision** roadway as a public road and accept perpetual maintenance of said street.

After the installation of the wearing surface, maintenance will be provided for an additional three-month minimum period on the wearing surface only.


