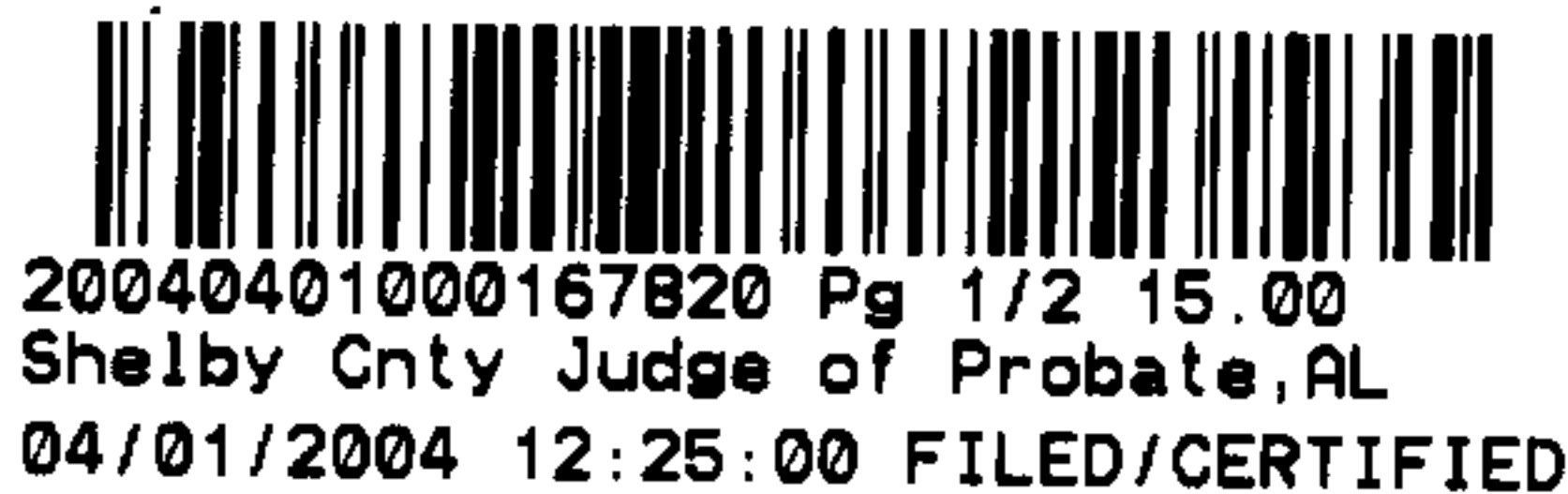

CORPORATION WARRANTY DEED
