KNOW ALL MEN BY THESE PRESENTS, That in consideration TWENTY EIGHT THOUSAND DOLLARS AND NO/00 (\$28,000.00), and other good and valuable considerations to the undersigned grantor (whether one or more), in hand paid by grantee herein, the receipt whereof is acknowledged, I or we, **FRANK MEREDITH AND WIFE, JANE MEREDITH (herein referred to as grantor)** grant, bargain, sell and convey unto, **RONALD BRYAN BURROUGHS AND UNA BURROUGHS (herein referred to as grantees)**, the following described real estate, situated in: Shelby County, Alabama, to-wit:
