KNOW ALL MEN BY THESE PRESENTS, that in consideration of \$263,500.00 and other valuable considerations to the undersigned GRANTOR or GRANTORS in hand paid by the GRANTEE(S) herein, the receipt whereof, is hereby acknowledged I/we, **EDDY L. INGRAM and PRISCILLA L. INGRAM, HUSBAND AND WIFE**, (herein referred to as GRANTOR(S), do hereby GRANT, BARGAIN, SELL and CONVEY unto **JAMES H. STONE, III and JULIE JOHNSTON STONE, HUSBAND AND WIFE**, (herein referred to as GRANTEE(S) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in the **County of SHELBY, and State of Alabama**, to-wit:


\$210,800.00 of the above consideration was paid from the proceeds of that mortgage closed simultaneously herewith.


