**ARTICLES OF INCORPORATION
OF

Pursuant to the provisions of the Alabama Business Corporation Act the undersigned hereby adopts the following Articles of Incorporation.

Article I:

The name of this corporation is WORLD POKER SHOP, INC.

Article II:

The primary purpose of this corporation is to engage in the sales, marketing and distribution of clothing, playing cards and other related products including any lawful act or activity for which a corporation may be organized under the laws governing corporations in the State of Alabama.

Article III:

The duration of this corporation is perpetual unless otherwise stated.

Article IV:

This corporation is authorized to issue only one class of shares of stock which shall be designated common stock. The total number of shares it is authorized to issue is 400 shares with a par value of one dollar per share.

Article V:
