

**Durable General Power of Attorney
To
Jasper and Dawn Carden**

KNOW ALL MEN BY THESE PRESENTS, that I, Katherine L. Carden, of 4580 Hwy. 71, Shelby, Alabama, 35143 being over the age of twenty-one (21) years, do hereby appoint Jasper and Dawn Carden of 171 Spring Creek Camp Road, Shelby, Alabama 35143, as my true and lawful attorneys and authorize and empower them for me and in my name to:

- (1.) Ask, demand, sue for, collect, recover, and receive all sums of money, debts, accounts, interest, dividends, annuities, and demands whatsoever as are now or shall hereafter become due, owing, payable or belonging to me, (personal and business).
- (2.) Make, do and transact all and every kind of business of whatever nature they considers necessary, to draw checks on all of my bank account or accounts and make deposits therein and perform any and all other banking functions, (personal and business).
- (3.) Make, seal, and deliver: to bargain, contract, agree for, buy, sell, mortgage, hypothecate, and in any and every way and manner deal in and with goods and personal property, in possession or in action, and to release mortgages on lands or chattels, (personal and business).
- (4.) Bargain, contract, agree for, purchase, receive and take lands, tenements, hereditaments and accept the seizen and possession of all lands and deeds, lease, bargain, sell, release and satisfy mortgages, release, convey, mortgage and hypothecate lands, tenements and hereditaments, upon such terms and conditions, and under such covenants, as shall be deemed advisable, (personal and business).
- (5.) Sign, seal, execute, acknowledge and deliver such deeds, leases and assignment of leases, agreements, mortgages, releases and satisfaction of mortgages and other such instructions in writing of whatever kind and nature as may be necessary or proper in the premises, (personal and business).
- (6.) Giving and granting unto Jasper and Dawn Carden, as my true and lawful attorneys, full power and authority to do and perform every act and thing whatsoever requisite and necessary to be done in an about the premises, including but not limited to the specific powers granted herein, as fully to all intent and purposes as I might or could do if personally present.
- (7.) I hereby ratify and confirm all that Jasper and Dawn Carden, are my true and lawful attorneys, shall lawfully do or cause to be done by virtue of these presents.

(8.) This power of attorney shall not be affected by disability. Incompetence or incapacity of principal.
