I, RAYMOND JACK RENSHAW, of the County of Jefferson, and State of Alabama, being of sound mind and disposing memory do hereby make, publish and declare this instrument as and for my Last Will and Testament, hereby revoking any and all Wills and Codicils heretofore made by me.

ARTICLE ONE

I direct that all of my legal debts, my funeral expenses, unpaid charitable pledges and the costs of administration of my estate be paid as soon as practicable after my death. My Personal Representative may in her sole discretion, pay from my domiciliary estate all or any portion of the costs of ancillary administration and similar proceedings in other jurisdictions.

ARTICLE TWO

I hereby give, devise and bequeath all the rest, residue and remainder of my estate, of whatsoever kind and character, and wheresoever situated, including real, personal and mixed property to my beloved children, DEBORAH ELAINE MEDVED and DENNIS WAYNE RENSHAW, in equal shares, ONE-HALF (1/2), each, share and share alike, absolutely and in fee simple or to their respective lineal descendants, per stirpes.

ARTICLE THREE

If my beloved children, **DERORAH ELAINE MEDVED**, **DENNIS WAYNE RENSCHAW**, and I die simultaneously, or under circumstances making it difficult or impossible to determine who died first, I direct that my children be deemed to have predeceased me and my estate shall be administered and distributed, in all respects, in accordance with such provisions, irrespective of any provisions of law establishing a contrary presumption.

ARTICLE FOUR

I appoint, **DERORAH ELAINE MEDVED**, to be my Personal Representative of this My Last Will and Testament. I direct that as my Personal Representative, she shall not be required to furnish any bond, nor file any inventory of property, or make any report or final settlement to any court of any proceedings hereunder. I further vest my said Personal Representative, with full power and authority to sell, transfer and convey any property, real or personal, which I may own or have control over at my death, without first obtaining permission from any court, at such time and price and upon such terms and conditions including credit as my said Personal Representative may determine and to do every other act and thing necessary or appropriate for the complete administration of my Estate. If, **DERORAH ELAINE MEDVED**, shall predecease me or for any reason shall fail to qualify as my Personal Representative hereunder, then in such event, I appoint **DENNIS WAYNE RENSCHAW**, as my Alternate Personal Representative of my Estate; and in such capacity shall possess and exercise all the powers and authority herein conferred on my Personal Representative. I direct that my Alternate Personal Representative shall not be required to furnish any bond, nor file any inventory of the property coming into his hands, or make any report or final settlement to any court of any proceedings hereunder.

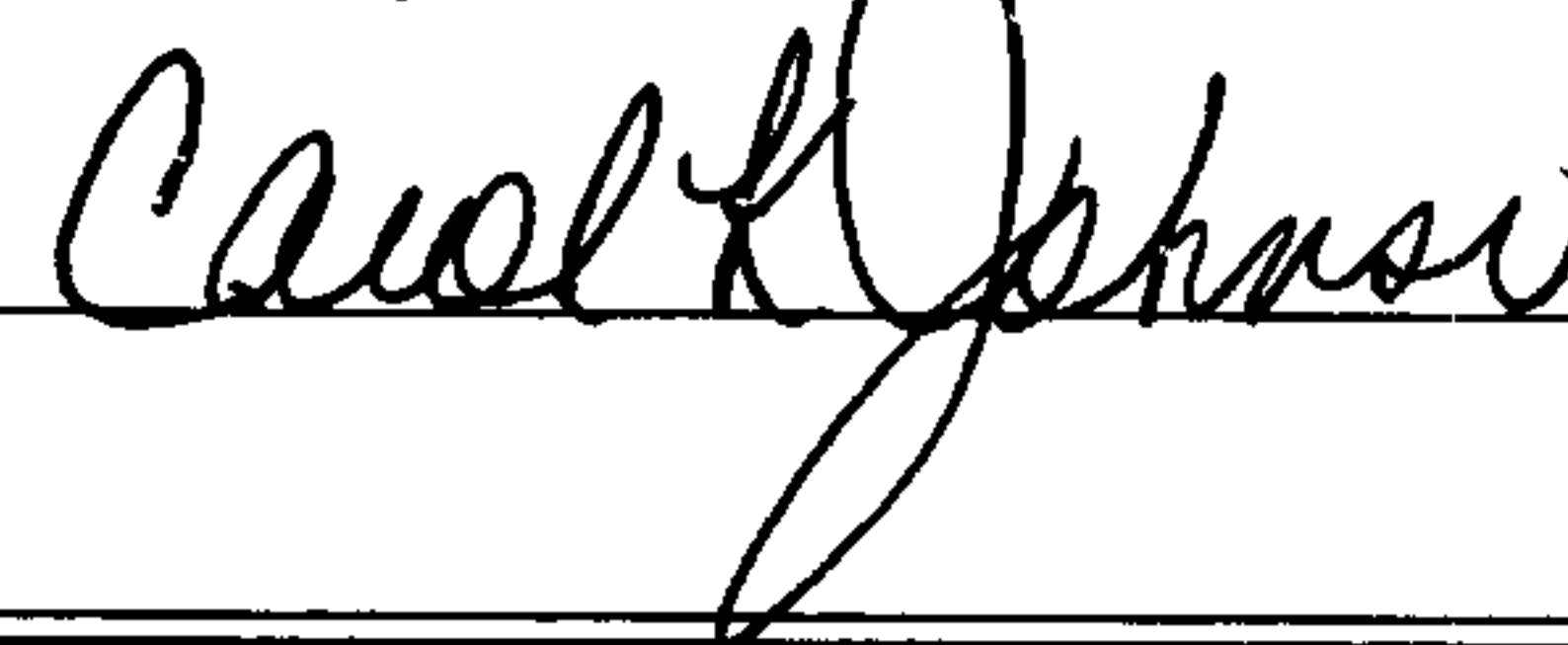
