Know All Men by These Presents: That in consideration of **Two hundred sixty six thousand one hundred ninety and no/100 (\$266,190.00)** to the undersigned grantor, a corporation, in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **R & C Enterprises, Inc.** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **David A. Goggans and Amy M. Goggans** (herein referred to as grantee, as joint tenants of survivorship whether one or more), the following described real estate, situated in **Shelby County, Alabama**, to-wit:

Mineral and mining rights excepted


Subject to existing easements, restrictions, set-back lines, right of way, limitations, if any of record.
