MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore on October 26, 2001, **Mildred Allen a/k/a Mildred Nelson Allen, Party of the First Part**, executed a certain mortgage to **Mortgage Electronic Registration Systems, Inc**, which said mortgage is recorded in Instrument No. 2001-52561, in the Office of the Judge of Probate of Shelby County, Alabama; and
