TERMINATION OF EASEMENT

THIS TERMINATION OF EASEMENT is made this // day of April, 2004, by SHELBY LAND PARTNERS, LLC, an Alabama limited liability company, and 3165 INVESTMENTS, LLC, an Alabama limited liability company (collectively, the "Owners").

WITNESSETH:

WHEREAS, pursuant to that certain agreement for Easement dated May 15, 1975, recorded in the Probate Office of Shelby County, Alabama in Deed Book 292, Page 372, Aslean Wright Swayne ("Swayne") granted to Charles Seales ("Seales") a right of way as more particularly described therein (the "Easement") over and across certain lands of Swayne (the "Swayne Property"), which Swayne Property is adjacent to certain lands of Seales (the "Seales Property"); and

WHEREAS, subsequent to the granting of the Easement, Seales conveyed the Seales Property to Plaza Pines, L.L.C., an Alabama limited liability company ("Plaza Pines"), and Plaza Pines then conveyed the Seales Property to the Owners; and

WHEREAS, subsequent to the granting of the Easment, Swayne conveyed the Swayne Property to the Owners; and

WHEREAS, as the current owners of both the property burdened by the Easement (i.e., the Swayne Property) and the property benefited by the Easement (i.e., the Seales Property), the Owners desire to extinguish, release and terminate the Easement.

NOW, THEREFORE, for the purposes set forth above, the Owners hereby declare that the Easement is hereby terminated and is of no further force or effect.
