

**AMENDMENT TO  
REAL ESTATE MORTGAGE AND SECURITY AGREEMENT**

This Amendment (the "Amendment") is made and entered into on March 26, 2004, by and between James G. Henderson and Pamela M. Henderson, a married couple (hereinafter called the "Mortgagor", whether one or more) and First Commercial Bank (hereinafter called the "Mortgagee").

**RECITALS**

A. James G. Henderson (hereinafter called the "Borrower", whether one or more) has (have) entered into as agreement entitled "First Commercial Bank Real Estate Mortgage and Security Agreement", executed by the Borrower in favor of the Mortgagee dated November 14, 1996 (the "Credit Agreement"). This Credit Agreement is in the amount of One hundred twelve thousand five hundred and no/100-- Dollars (\$112,500.00 ).


B. The Mortgagor has executed in favor of the Mortgagee a Real Estate Mortgage and Security Agreement (the "Mortgage") recorded December 17, 1996 in Inst.# 1996-41517, in the Probate Office of Shelby County, Alabama.


