

**ARTICLES OF INCORPORATION
OF
INSPECTIONS AND PRESERVATIONS, INC.**

**TO THE HONORABLE JUDGE OF PROBATE OF SHELBY
COUNTY, ALABAMA:**

**Pursuant to the provisions of the Alabama Business Corporation
Act, The undersigned hereby adopts the following Articles of
Incorporation.**

ARTICLE I: The name of the corporation shall be:

Inspections and Preservations, Inc.

ARTICLE II: The duration of the corporation shall be perpetual.

**ARTICLE III: The objects and powers for which the corporation is
formed are:**

**1) To establish, maintain, conduct and operate markets,
stores, boutiques, shops and stores of every kind, nature, and
description; to purchase, buy, sell, exchange, grow, produce,
manufacture, process, market, export, import, handle, store, distribute,
and otherwise generally deal in any and all articles of merchandise,
both at wholesale and retail, and acquire, construct and maintain,
operate and sell or dispose of factories, plants, warehouses, machinery
and equipment, markets, stores, depots and gatherings, delivery routes
and systems for such purposes.**

2) To carry out any one or more of the purposes and objects herein enumerated as principal factor, agent, contractor, or otherwise, either alone or through or in conjunction with any person, partnership, association, or corporation.

3) To have and to exercise all the powers now or hereafter conferred by the laws of the State of Alabama upon corporations organized pursuant to the laws under which the corporation is organized and all acts amendatory thereof, and supplemental thereof.

ARTICLE IV: The total authorized stock shall be 100 shares consisting of a par value of \$1 per share. All stock shall be common stock and non-assessable. The amount of capital with which the corporation will begin business is \$1000, all of which shall be paid by the initial stockholders.


