AMENDMENT TO MORTGAGE AND SECURITY AGREEMENT

This Amendment to Mortgage and Security Agreement is entered into as of April 2, 2004.

THE NARROWS II, INC., an Alabama corporation ("Grantor") has made and delivered to **SOUTHTRUST BANK**, an Alabama banking corporation ("Bank"), a Mortgage and Security Agreement ("Mortgage") dated February 24, 2004, recorded in Instrument no. 20040311000125760 with the Judge of Probate of Shelby County, Alabama in order to secure a Promissory Note from Thornton Construction Company, Inc. ("Borrower") dated February 24, 2004 (as the same may hereafter be extended, renewed, amended, or modified, the "Note") evidencing a revolving loan in the principal amount of up to Ten Million and No/100 Dollars (\$10,000,000.00) outstanding from time to time, interest thereon and certain other indebtedness and obligations of Borrower and Grantor (or either of them) from time to time owing to Bank.

Grantor and Bank mutually desire to amend the Mortgage in order to correct an error therein.

NOW, THEREFORE, in consideration of the above provisions, and in further consideration of the mutual covenants contained in this Amendment, the parties agree as follows:

1. Amendments to Mortgage. The Mortgage is amended by replacing the word "Lender" each place it appears in Section 4.5 of the Mortgage with the term "Bank."
2. Continued Effectiveness of Documents. In all other respects the Mortgage shall remain unchanged and in full force and effect, and Grantor affirms that it has no offsets or defenses to its obligations pursuant to the Mortgage or other documents executed in connection therewith.
