Know All Men by These Presents: That in consideration of **Two hundred nine thousand nine** hundred and no/100 (\$209,900.00) to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Pamela Hillman and Joshua** Hillman, wife and husband (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto Jerome F. Reilly and Shahna S. Reilly (herein referred to as grantee, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot 19, according to the Map and Survey of Old Cahaba II-B, as recorded in Map Book 30, Page 28, in the Probate Office of Shelby County, Alabama.

Mineral and mining rights excepted.
