**WARRANTY DEED, JOINTLY FOR LIFE**  
**WITH REMAINDER TO SURVIVOR**

KNOW ALL MEN BY THESE PRESENTS, That in consideration of other good and valuable considerations and the sum of **One Hundred Thirteen Thousand Five Hundred and 00/100 Dollars** (\$113,500.00) to the undersigned GRANTORS in hand paid by the GRANTEEES herein, the receipt of which is hereby acknowledged, **Henry Samuel Tate, II and Melissa Tate, husband and wife** (hereinafter referred to as GRANTORS), do hereby grant, bargain, sell and convey unto **Javier Pineda Gutierrez and Patricia Pineda, husband and wife** (hereinafter referred to as GRANTEEES), for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in the County of Shelby and State of Alabama, to-wit:
