CORPORATION WARRANTY DEED-Joint Tenants with rights of survivorship

COUNTY OF SHELBY } KNOW ALL MEN BY THESE PRESENTS:

THAT IN CONSIDERATION OF Two Hundred Nine Thousand Nine Hundred and no/100 Dollars (\$209,900.00) to the undersigned grantor, D. R. Builders, Inc., a corporation, in hand paid by the grantee herein, the receipt of which is hereby acknowledged, the said D.R. Builders, Inc.

does by the presents, grant, sell, bargain and convey unto the said Fameka Leonard and Keldrick Leonard

(herein referred to as Grantee(s)) for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate, situated in SHELBY COUNTY, Alabama to wit:

Lot 1011, according to the Survey of The Arbores of Forest Parks, as recorded in Map Book 25, Page 146, in the Probate office of Shelby County, Alabama.

Subject to easements, set back lines, restrictions, covenants, mineral and mining rights and current taxes not due.

\$209,900.00 of consideration above paid from the proceeds of a purchase money mortgage closed herewith.
