To make, seal and deliver, bargain, contract for, agree for, lease, purchase, exchange, receive, and take any real or personal property whatsoever, and accept the possession of such property, and all deeds, contracts, bills or sale, and other assurances in the law therefor, and to lease, let, demise, bargain, sell, remise, release, convey, mortgage, and hypothecate such property upon such terms and conditions and under such covenants as my attorney-in-fact shall think fit, and to maintain, repair, improve, manage, and insure such property under such terms, conditions and

it, limit or restrict the general powers herein granted to said attorney-in-fact.

This power of attorney shall not be affected by my disability, incompetency, or incapacity.

If, following execution of this power of attorney, a court of my domicile appoints a guardian,

conservator, or other fiduciary charged with the management of all or a portion of my property, the

court shall appoint Jo Ann H. Victory, except for good cause or disqualification.
