WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of Three Hundred Ninety Thousand and 00/100 Dollars (\$390,000.00) and other good and valuable considerations, the receipt and sufficiency of which are hereby acknowledged, First Methodist Church of Calera, an Unincorporated Church, hereinafter called "Grantors," do hereby GRANT, BARGAIN, SELL AND CONVEY unto South Shelby Baptist Church, Inc., hereinafter called "Grantee" in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in Shelby County, Alabama, to-wit:

Note: First Methodist Church of Calera and Calera First United Methodist Church are one and the same entities.

PURCHASE MONEY FIRST MORTGAGE EXECUTED BY GRANTEE(S), ON EVEN DATE HEREWITH, IN FAVOR OF CENTRAL STATE BANK, IN THE SUM OF \$390,000.00.

TO HAVE AND TO HOLD to the said Grantee in fee simple forever, together with every contingent remainder and right of reversion.
