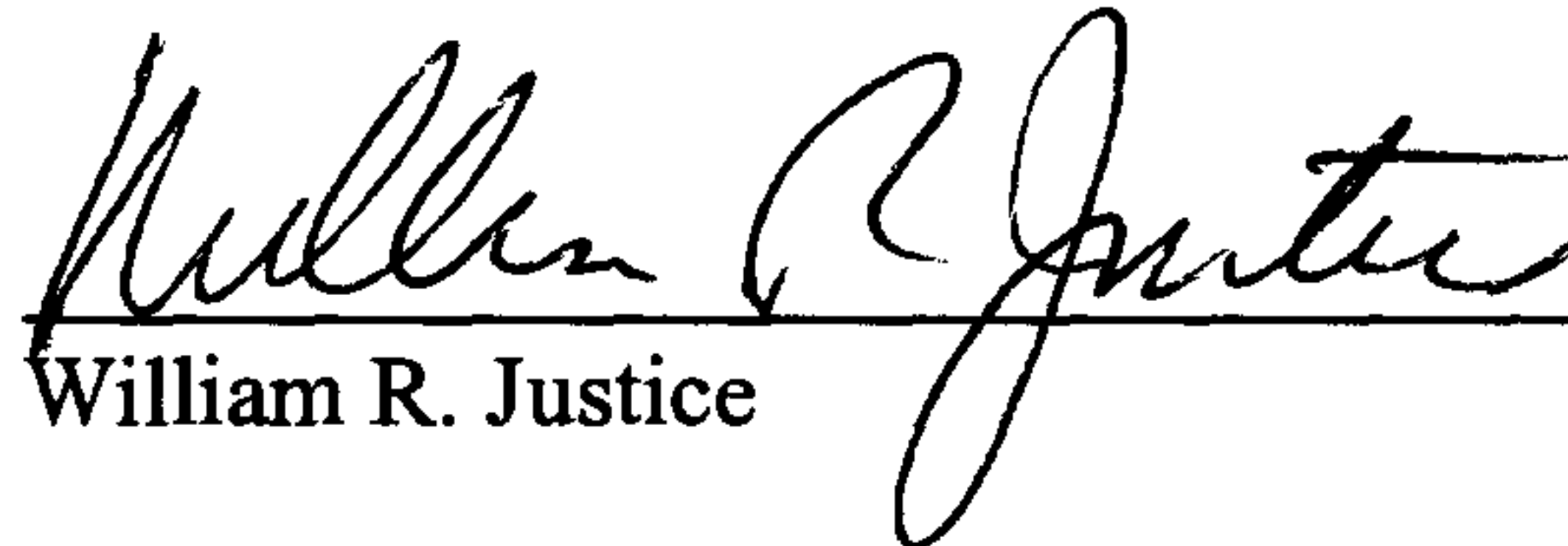
AFFIDAVIT

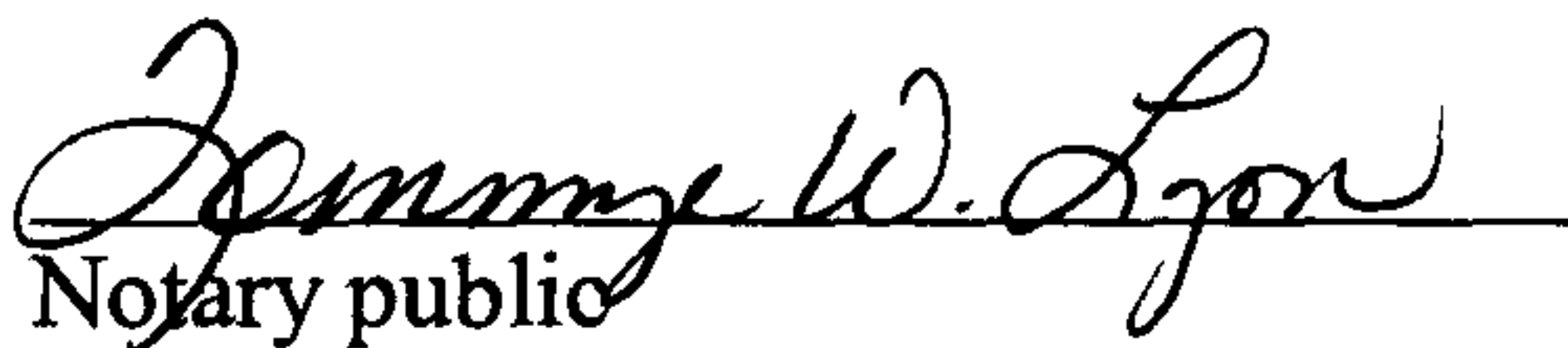
