KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore on June 16, 2003, **Patricia W. Collum, a single woman, Party of the First Part**, executed a certain mortgage to **Long Beach Mortgage Company**, which said mortgage is recorded in Real Property Book 2003, Page 40717, in the Office of the Judge of Probate of Shelby County, Alabama Which said Mortgage was last sold, assigned and transferred to Deutsche Bank National Trust Company, as Trustee for Long Beach Mortgage Loan Trust 2003-4; and


