



## ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation under the Code of Alabama, adopt the following Articles of Incorporation for such corporation:

**FIRST:** The name of the corporation is Jimmie Parker Custom Homes, Inc.

**SECOND:** The period of its duration is perpetual.

**THIRD:** The purpose or purposes for which the corporation is organized are Construction of new homes and any other business which may lawfully be conducted in the State of Alabama.
