Know All Men by These Presents: That in consideration of **One hundred fifty eight thousand three hundred and no/100 (\$158,300.00)** to the undersigned grantor, a corporation, in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Gardner Builders, Inc.** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Curtis Smith and Essie B. Smith** (herein referred to as grantee, as joint tenants of survivorship whether one or more), the following described real estate, situated in **Shelby County, Alabama**, to-wit:

Mineral and mining rights excepted


Subject to existing easements, restrictions, set-back lines, right of way, limitations, if any of record.
