KNOW ALL MEN BY THESE PRESENTS, that in consideration of the sum of Three Hundred Fifty-One Thousand Seven Hundred Thirty and no/100 Dollars (\$351,730.00) and other good and valuable consideration to the undersigned grantors, in hand paid by the grantee herein, the receipt of which is hereby acknowledged **DABNEY HOMES, INC.**, (herein referred to as "Grantor"), hereby grants, bargains, sells, and conveys unto **BRYONDA W. HAYWOOD and FRANKLIN A. HAYWOOD**, (herein referred to as "Grantee"), as joint tenants with rights of survivorship, their interest in the following described real estate situated in SHELBY County, Alabama, to wit:

Lot 213, Sector 2, according to the Final Plat, The Woodlands, Sectors 2, 4 and 5, as recorded at Map Book 29, Page 99, in the Probate Office of Shelby County, Alabama.

Subject to all easements, restrictions, covenants, rights of way of record; taxes for 2004 and subsequent years not yet due and payable.


\$351,730.00 of the purchase price recited herein was paid from the proceeds of two mortgage loans closed simultaneously herewith.

AND THE GRANTOR does for its successors and assigns, covenant with said Grantee, their heirs, executors, successors and assigns, that Grantor is lawfully seized in fee simple of the premises, that they are free from all encumbrances, unless otherwise noted above, that Grantor has good right to sell and convey the same as aforesaid, and that Grantor will and its successors and assigns shall warrant and defend same to said Grantee, their heirs, executors, successors and assigns forever, against the lawful claims of all persons.


