Know All Men by These Presents: That in consideration of **One hundred fourteen thousand four hundred and no/100 (\$114,400.00)** to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Sherry Yeager-Zitrick f/k/a Sherry D. Yeager, a married woman** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Tammy L. Jenkins and Larry Jenkins** (herein referred to as grantee, whether one or more), the following described real estate, situated in **Shelby County, Alabama**, to-wit:
