Know All Men by These Presents: That in consideration of **One hundred twenty five thousand and no/100 (\$125,000.00)** to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Fay A. Nelson, as personal representative of the Estate of Betty Travis, deceased, Probate Case No. 2004-45** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Venitta Smith Woodall and Reggie Woodall and Bernice L. 
