EXHIBIT "A" LEGAL DESCRIPTION:

A lot or parcel of land located in the Northeast ¼ of the Southeast ¼, Section 35, Township 21, Range 3 West, Shelby County, Alabama, more particularly described as follows: Begin at the Northeast corner of the Northeast ¼ of the Southeast ¼ of Section 35, Township 21, Range 3 West run thence West along the North boundary line of said quarter-quarter Section a distance of 210 feet to a point; thence run South and parallel with the East boundary line of said quarter-quarter Section a distance of 210 feet to a point; run thence East and parallel with the North line of said quarter-quarter Section a distance of 210 feet to a point on the East line of said quarter-quarter Section; thence North along said East line a distance of 210 feet to point of beginning.
