

EXHIBIT "A" LEGAL DESCRIPTION (LUNSFORD TO HONEYCUTT)

From the SW corner of the NW 1/4 of the SW 1/4, Section 10, Township 19 South, Range 1 West, Shelby County, Alabama, run in an easterly direction along the south line of said 1/4-1/4 Section line for a distance of 595.46 feet to an existing iron pin being the point of the beginning; thence continue in an easterly direction along the south line of said 1/4-1/4 Section line for a distance of 292.54 feet to an existing iron pin; thence turn an angle to the left of 90 degrees 05 minutes 45 seconds and run in a northerly direction for a distance of 200.0 feet to an existing iron pin; thence turn an angle to the left of 89 degrees 54 minutes 15 seconds and run in a westerly direction for a distance of 292.54 feet to an existing iron pin; thence turn an angle to the left of 90 degrees 05 minutes 45 seconds and run in a southerly direction for a distance of 200.0 feet, more or less, to the point of beginning, containing 1.34 acres, more or less.
