

# AMENDMENT TO ARTICLES OF INCORPORATION OF DAVENTRY RESIDENTIAL ASSOCIATION.

Pursuant to the approval by a majority of the members of the Daventry Residential Association the following amendments of Articles of Incorporation, duly filed, 12/07/1999, as inst. # 1999-49454, are as follows:

### Amended Article V, and Article VI

### Article V: INITIAL REGISTERED OFFICE AND AGENT

The registered office of the Association shall be 496 Daventry Circle, Calera, Al 35040. The registered agent of the Association shall be Michael F. Ghareeb, President.

#### Article VI: BOARD OF DIRECTORS

The business and affairs of the Association shall be managed by a Board of Directors consisting of no less than three (3) nor more than five (5) directors. Change in the maximum number of directors shall be permitted by amendment to the Articles of Incorporation, or by amendment to the Bylaws. The Board of Directors shall be elected by each of the members of the Association entitled to vote.
