STATUTORY WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS THAT in consideration of Forty Thousand and No/100 Dollars (\$40,000.00), and other good and valuable consideration, paid to the undersigned grantor, Wild Timber Development, L.L.C., an Alabama limited liability company ("Grantor"), by Brantley Homes, Inc. ("Grantee"), the receipt and sufficiency whereof are hereby acknowledged, Grantor does by these presents, grant, bargain, sell and convey unto the Grantee the following described real estate situated in Shelby County, Alabama (the "Property"), to-wit:

Lot 14, according to the Final Plat of Wood Ridge, as recorded in Map Book 30, at Page 7, in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama

SUBJECT TO: (1) Current taxes; (2) Building setback line of 35 feet reserved from Wood Ridge, as shown by plat; (3) Restrictions, covenants and conditions as set out in instrument(s) recorded in Inst. No. 20020627000301940 in the Probate Office; (4) Title to all minerals within and underlying the premises, together with all mining rights and other rights, privileges and immunities relating thereto, including rights set out in Inst. No. 1997-9552 and Inst. No. 2000-04451 in the Probate Office; (5) Easement(s) to Plantation Pipeline as shown by instrument recorded in Deed 253, at Page 324, in the Probate Office; (6) Restrictions, limitations and conditions as set out in Map Book 30, at Page 7, in the Probate Office.
