That in consideration of **ONE HUNDRED NINETY THOUSAND SEVEN HUNDRED FORTY AND NO/100-----DOLLARS (\$190,740.00)**, to the undersigned grantor, **J.D.S. HOMES, INC.**, a corporation, (herein referred to as **GRANTOR**), in hand paid by the **GRANTEES** herein, the receipt of which is hereby acknowledged, the said **GRANTOR** does by these presents, grant, bargain sell and convey unto **SAM F. DAVIS and wife, KIMBERLY L. DAVIS** (herein referred to as **GRANTEES**), for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in Shelby County, Alabama, described as follows:

Lot 525-A, a resurvey of Lots 525 through 530 and 518 through 520, according to the final plat of Windstone Phase 5, as recorded in Map Book 31, Page 144, in the Office of the Judge of Probate of Shelby County, Alabama.

\$152,592.00 of the above recited purchase price was paid by a mortgage recorded simultaneously herewith.

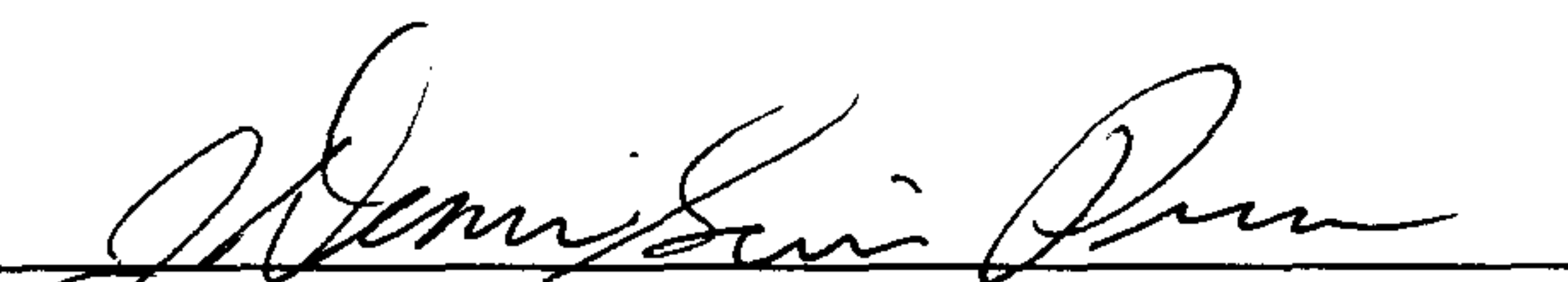
\$28,611.00 of the above recited purchase price was paid by a second mortgage recorded simultaneously herewith.

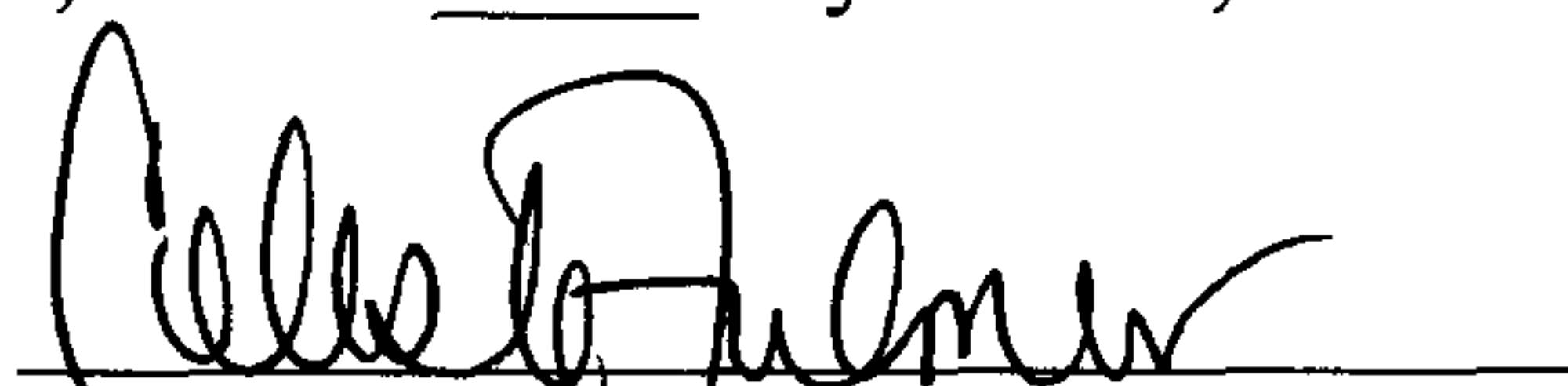
