Commence at the NW corner of the SWk of Section 22, Township 19 South, Range 2 West; thence run East along the North line of said SWk a distance of 649.8 feet; thence turn an angle to the right of 87 degrees 46 30 and run in a Southerly direction for a distance of 127.36 feet to the point of beginning; from the point of beginning thus obtained, thence continue along last described course for a distance of 115.00 feet; thence turn an angle of 92 degrees 12 47 to the right and run in a Westerly direction for a distance of 310.71 feet to the East right-of-way boundary of Cherokee Trail; thence run in a Northerly direction along the East right-of-way line of Cherokee Trail to a point 127.29 feet Southerly of the North line of the SWk of Section 22, Township 19 South, Range 2 West; thence run in an Easterly direction, parallel with said North line of the SWk for a distance of 308:48 feet to the point of beginning.
