

## PARTIAL RELEASE FROM MORTGAGE AND ASSIGNMENT OF RENTS

As to all other land described and conveyed in said Mortgage and Assignment, the lien thereof shall remain in full force and effect, unaffected by this release.

This release is given for the purpose of enabling AIG Baker East Village, L.L.C., to make a valid conveyance of said Property free and clear of the lien of said Mortgage and Assignment.
