Parcel One - Fee Simple Acquisition:


A part of the NW¼ of SW¼, Section 19, Township 20 South, Range 2 West identified as Tract No. 10 on Project No. STPBH-7280(600), Shelby County, Alabama and being more fully described as follows;

Commencing at the northwest corner of said NW¼ of SW¼; thence easterly along the north line of said NW¼ of SW¼ a distance of 699.30 feet to the point of intersection with the Grantor's eastern property line; thence south along said property line for a distance of 800.42 feet to a point 66.76 left of the CR 52 centerline of Project No. STPBH-7280(600) station 48+66.67 being the point of beginning of the property herein to be conveyed; thence south along the Grantor's eastern property line for a distance of 6.53 feet to the point of intersection with the present northern right-of-way line of CR 52; thence N50°49'20"W along said present right-of-way line for a distance of 77.15 feet to a point 67.25 feet left of said centerline station 47+93.25; thence S54°53'29"E for a distance of 73.11 feet to the point of beginning. Containing 0.01 acre, more or less.

Parcel Two - Temporary Construction Easement:

TEMP. CONSTRUCTION EASMENT NO.1: A temporary easement, necessary for construction, more fully described as follows: Beginning at a point 85.17 feet left of the CR 52 centerline of Project No. STPBH-7280(600) station 48+53.39; thence along the Grantor's eastern property line for a distance of 22.71 feet to the point of intersection with the required right-of-way line; thence N53°29'18"W along the required rightof-way line for a distance of 19.57 feet to a point 67 feet left of said centerline station 48+47.00; thence N53°55'25"E for a distance of 19.23 feet to the point of beginning. Containing 0.01 acre, more or less. TEMP. CONSTRUCTION EASMENT NO.2: Beginning at a point 67.25 feet left of the CR 52 centerline of Project No. STPBH-7280(600) station 47+93.55; thence N34°50'40"E for a distance of 26.75 feet to a point 94.00 feet lest of said centerline station 47+93.55; thence S55°09'20"E for a distance of 35.00 feet to a point 94.00 feet left of said centerline station 48+28.55; thence S34°50'40"W for a distance of 29.35 feet to the point of intersection with the required right-of-way line; thence N54°53'29"W for a distance of 35.00 feet to the point of beginning. Containing 0.02 acre, more or less.

Upon completion of said project, all right, title and interest to said temporary easements shall cease and the grantee hereby relinquishes same.
