ARTICLES OF ORGANIZATION
OF
SPREADRITE ORGANICS, LLC

Pursuant to the Provisions of Act No. 93-724 of the 1993 Alabama Legislature or the Alabama Limited Liability Company Act, the undersigned hereby adopt the following Limited Liability Company Articles of Organization:

ARTICLE I

Name

The name of the limited liability company (the "Company") is SpreadRite Organics, LLC.

ARTICLE II

Period of Duration

The period of duration for the Company is perpetual.

ARTICLE III

The Company has been organized for the purpose of providing mulch and other organic spreading services.


