ARTICLES OF ORGANIZATION OF HENDERSON INVESTMENTS, LLC

TO THE HONORABLE JUDGE OF PROBATE OF SHELBY COUNTY, ALABAMA:

The undersigned, for the purpose of forming a limited liability company pursuant to the provisions of the Alabama Limited Liability Company Act, <u>Code of Alabama</u>, Section 10-12-1 *et seq.* (the "Act"), hereby certifies as follows:

1. NAME. The name of the limited liability company (the "Company") is:
