KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of Two Hundred Seventy-Nine Thousand Nine Hundred and 00/100 (\$279,900.00) DOLLARS, and other good and valuable consideration, this day in hand paid to the undersigned GRANTOR, **Don Martin Construction Company, Inc., a corporation** (hereinafter referred to as GRANTOR), the receipt whereof is hereby acknowledged, the GRANTOR does hereby give, grant, bargain, sell and convey unto the GRANTEES, **Timothy P. Ferguson and Christina D. Ferguson, husband and wife**, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of SHELBY, State of Alabama, to-wit:

Lot 407, according to the Final Plat of Stoneykirk at Ballantrae, Phase 1, as recorded in Map Book 32 page 11, in the Office of the Judge of Probate of Shelby County, Alabama; being situated in Shelby County, Alabama.

Subject to existing easements, current taxes, restrictions and covenants, set-back lines and rights of way, if any, of record.
