Commence at the Southeast corner of the Southwest quarter of the Northwest quarter of said Section 31, said point being on the South line of Lot 1A, a Resubdivision of Lot 1, Brook Highland O & I No. 1, as recorded in Map Book 26, Page 80, in the Office of the Judge of Probate of Shelby County, Alabama; thence run Easterly along the South line of said subdivision of said Lot 1A for a distance of 55.63 feet to the point of beginning; thence turn an interior angle to the right of 105 degrees 43 minutes 17 seconds and run Northerly for a distance of 129.50 feet; thence turn an interior angle to the left of 207 degrees 12 minutes 29 seconds and run Northerly for a distance of 74.21 feet; thence turn an interior angle to the left of 152 degrees 47 minutes 31 seconds and run Northerly for a distance of 245.00 feet; thence turn an interior angle to the left of 152 degrees 50 minutes 50 seconds and run Northeasterly for a distance of 82.40 feet to a point on a curve to the left, said curve having a radius of 1742.21 feet; thence run Southeasterly along the Arc of said curve for an arc length of 446.12 feet (Delta = 14degrees 40 minutes 18 seconds, Chord Length = 444.90 feet, interior angle left to chord = 54 degrees 09 minutes 54 seconds) to a point of tangency with said curve thence run Southeasterly along the tangent of said curve for a distance of 60.47 feet; thence turn an interior angle to the left of 71 degrees 22 minutes 24 seconds and run Westerly for a distance of 249.18 feet to the point of beginning
