**KNOW ALL MEN BY THESE PRESENTS**, that in consideration of the sum of Four Hundred Forty-Seven Thousand and no/100 Dollars (\$447,000.00 ) and other good and valuable consideration to the undersigned grantors, in hand paid by the grantee herein, the receipt of which is hereby acknowledged, **LINDA FAY MASON POPE aka LINDA FAYE POPE and husband, GARY PHILLIP POPE**, (herein referred to as "Grantor"), hereby grants, bargains, sells, and conveys unto, **MARTIN RUSSELL MOULTRIE and KATHY M. MOULTRIE**, (herein referred to as "Grantees") , as joint tenants with rights of survivorship, their interest in the following described real estate situated in SHELBY County, Alabama, to wit:

Lot 4, according to the Survey of Willowbrook, as recorded in Map Book 11, Page 48 in the Probate Office of Shelby County, Alabama.

Subject to all easements, restrictions, covenants, rights of way of record; taxes for 2004 and subsequent years not yet due and payable.


\$200,000.00 of the purchase price was paid from the proceeds of a mortgage loan closed simultaneously herewith.
