POWER OF ATTORNEY

The undersigned Washington Mutual Finance Corporation, a Delaware Corporation duly represented by Jeffrey A. in such forms as any attorney-in-fact may approve and to do all such acts and things as may be ancillary thereto and/or necessary and/or useful and/or desirable in the sole opinion of any attorney-in-fact in connection with or for the purpose of the entering into, execution or performance of any agreement relating to, and the performance of, the Services.

This Power of Attorney and the rights and duties of the undersigned and the attorneys-in-fact hereunder shall be governed by, and construed in accordance with, the law of the state of Delaware.
